## USDA-NRCS Now Accepting Applications for Assistance to Organic Farmers via the Environmental Quality Incentives Program

Tillman, Sr., State Conservationist for the USDA-Natural Resources Conservation Service (NRCS) in Georgia today announced that the NRCS is now accepting applications for technical and financial assistance through the Environmental Quality Incentives Program (EQIP) organic initiative. Applications must be received by March 12, 2010, to be considered for funding. NRCS in Georgia has one million dollars available for this initiative.

The 2008 Farm Bill included provisions for use of EQIP to provide opportunities for organic growers as well as requirements related to adherence to the National Organic Program (NOP) requirements and program payment limitations.

Financial and technical assistance is available to help USDA-Certified organic producers and those in the process of transitioning to organic farming. Assistance from the NRCS through the EQIP program helps producers plan and implement conservation practices that conserve and enhance natural resources.

EQIP is primarily used to provide financial and technical assistance to implement conservation practices to address soil, water, air, plant, and animal resources. Through this initiative, NRCS will provide assistance for conservation practices related to organic production.

This assistance is limited to \$20,000 per year and \$80,000 during a six-year period. Producers are required to develop and carry out an Organic System Plan (OSP) or carry out practices consistent with an OSP and producers must be in compliance with their organic certification or in the process of pursuing USDA organic certification. ❖
