## Chamberlain Hrdlicka Extends the Lease on its Downtown Houston Headquarters in Allen Center and Announces Major Renovation

Under the terms of the new agreement, Chamberlain Hrdlicka will lease 55,178 square feet of contiguous space in the Two Allen Center office tower on the 13<sup>th</sup> and 14<sup>th</sup> floors. Brookfield Properties was represented by CBRE’s Bubba Harkins, Russell Hodges and Jessica Ochoa in the lease negotiations.

The skybridge connection between the Allen Center buildings allows tenants to take full advantage of the campus, which boasts retail bays where they can enjoy food and beverage offerings such as Guard and Grace, Rosalie Italian Soul, Mendocino Farms and a variety of tunnel-level eateries in The Court.

Allen Center has achieved LEED ED O&M Gold certification, Energy Star certification and is WELL Health-Safety rated by the International WELL Building Institute (IWBI).
