She has previously served in numerous other HBA committee chair positions and volunteer roles, including the County Law Library Committee, the Law and the Media Committee, the Dispute Resolution Committee, the Administration of Justice Committee for the Criminal District/Appellate Bench Bar Conference, and the Harvest Celebration Fundraising Committee. She is the past president of the Hispanic Bar Association of Houston, where she currently sits on the Board of Directors. She has also served on the Board of Directors for the Mexican-American Bar Association of Houston, as a member of the Harris County Bench Bar Pro Bono Awards Committee, and as a committee member for the inaugural and second Southern District of Texas Houston/Galveston Bench-Bar Conferences. Furthermore, she has also served on the Board of Directors for the Houston Zoo Development Corporation.

In recognition of her professional accomplishments and community involvement, Diana has been named one of Houstons 50 Most Influential Women of 2020-21 by *Houston Woman Magazine*. She was named to the Texas Super Lawyers list by Super Lawyers consecutively every year since 2013 and was among the Texas Super Lawyers 2020 Top Women. She was also named to Best Lawyers in America 2022 and 2023. Additional accolades include: Top Lawyer in 2017 - 2022 by *Houstonia Magazine*; the Latina Lawyer Under 40 Award from the Mexican American Bar Association of Texas Foundation in 2012; the HBAs President's Award in 2016 and 2019; the Hispanic Bar Association of Houstons Presidents Award in 2007, 2009, 2015 and 2019; the Local Heroes Recognition by the Houston Lawyer Magazine in 2009; and the Woodrow B. Seals Outstanding Young Lawyer of Houston Award from Houston Young Lawyers Association in 2008. She is a Life Fellow of the American Bar Foundation, Texas Bar Foundation, and the Houston Bar Foundation.
