Ken Trujillo Joins Chamberlain Hrdlicka

Prominent litigator and former Democratic candidate for Philadelphia mayor moves law practice to Philadelphia office of Chamberlain Hrdlicka

He counsels clients on regulatory matters and internal investigations, and has represented public officials and government entities, including city council members, mayors, governors, states, cities and Native American tribes in civil and criminal matters. Beyond his litigation experience, Trujillo has broad experience in the planning of large-scale projects ranging from sports stadiums to casinos.

Ed Rendell's Transition Team. Shortly after, Rendell appointed Trujillo to the Board of Directors of the Pennsylvania Inter-Governmental Cooperation Authority, the Board of Commissioners of the Delaware River Port Authority, and as a Commissioner of the Pennsylvania Gaming Control Board.
