Appeals & Other Post-Conviction Proceedings: Alex also regularly represents clients in criminal appeals and those seeking other post-conviction relief, as well as clients in probation violation proceedings.

Expungements: The law and procedures on expungements have evolved in recent years to create more clean slate opportunities. Although specific requirements must be met, and many old convictions still do not qualify for expungement, Alex enjoys working with clients to ascertain their eligibility, and then pursue an expungement, or setting aside of their old convictions, if applicable. **Expungement Process in Michigan**
