



## Freedom of Information Act

Some of the FOIA questions and issues that we frequently help our clients confront include:

- Does the FOIA apply if a request does not specifically reference the FOIA or is not submitted on an official FOIA form?
- Must "public records" that are contained on an official's personal computer be turned over?
- How quickly must a response be delivered, and how can extensions be obtained?
- What must be done to properly deny a request?
- How, when, and for what should fees be collected from the requester?
