Mike currently represents, among others, Visa as a defendant in multibillion-dollar national antitrust class actions and opt-out litigation relating to network rules at the heart of the Visa system, Chubb in national coverage litigation relating to opioids (and other high-stakes coverage litigation), H.I.G. Capital in a fraud case, bank trustees including HSBC and U.S. Bank on claims relating to mortgage-backed securities, a hybrid electric aircraft startup on trade secret claims against Boeing, and various other clients navigating high stakes and complex disputes.

Mike has represented numerous clients in high-profile and highly contested domestic and cross-border matters across a variety of disciplines and in a multiplicity of fora, and has successfully tried cases and argued appeals in federal and state courts throughout the United States. He has extensive experience in and has secured favorable awards in arbitrations under the ICC, AAA, LCIA, JAMS, and other rules.

Before co-founding Holwell Shuster & Goldberg, Mike was a litigation partner at White & Case, where he served as Global Head of Commercial Litigation, and at Kasowitz, Benson.
