### Growing emphasis on recruiting top attorneys

The project, located in Oakland Park, is a win not only for our client but represents the realization of a true public-private partnership between our client, its local religious institutional partner, the city of Oakland Park and Broward County, all of whom have come together to provide much-needed affordable housing for first responders, working professionals, and others in the workforce but also to revitalize and sustain the surrounding neighboring community and single family home owners for the years to come.

Beyond affordable housing, we've also supported infrastructure and master planning initiatives. For example, the firm has been collaborating with a wellknown developer on a major community-driven master plan for downtown Pompano Beach. This ambitious project includes a city hall, mixed-use developments, and public spaces designed to integrate residential, office, and commercial areas seamlessly.
