Prior to joining Shutts, Denise served as senior counsel at a national legal nonprofit organization, where she led litigation and advocacy efforts in state and federal courts, including the U.S. Supreme Court. She served as Deputy Solicitor General in the Office of the Florida Attorney General from 2015 to 2017, where she drafted appellate briefs and presented oral arguments on behalf of the State of Florida in a wide variety of constitutional cases. In 2017, Denise was selected for the prestigious U.S. Supreme Court Fellowship through the National Association of Attorneys General. Denise clerked for the Honorable Justice Ricky L. Polston on the Florida Supreme Court before working as an appellate litigator for several years in California. In 2019, Denise was chosen as a gubernatorial appointment to Florida's Faith and Community Advisory Council, where she continues to serve. In 2022, Denise was selected as a finalist for a seat on the Florida Supreme Court. In 2024, Denise was appointed by Governor DeSantis to the Judicial Nominating Commission for the Second Circuit, where she continues to serve.

Denise has also been involved with several nonprofit and community groups. She is a member of American Enterprise Institute's Leadership Network and The Federalist Society for Law and Public Policy's Speakers Bureau. She has also served on the board of Tallahassee Women Lawyers and as a committee member for The Florida Bar's Client Security Fund, and is a member of the First District Appellate American Inn of Courts. Denise serves on the board of directors for Making Miracles Group Home and is a member of City Church Tallahassee.
