Tara's representative experience also includes helping to secure a key victory for Florida's electric cooperatives in a high-profile matter before the Florida Supreme Court, which resulted in the rejection of a proposed constitutional amendment that would have radically altered the way Florida's electric cooperatives and other electric utilities operate their utility businesses. In addition to successfully representing regional associations of Florida Pilots seeking rate increases before the Florida Pilotage Rate Review Committee and Board of Pilot Commissioners, Tara has also represented Florida's business interests before the Florida Supreme Court in matters such as the Daubert evidentiary rule and Florida's summary-judgment procedure.

Prior to her private practice experience, Tara was a judicial law clerk for the Honorable Adalberto Jordan of the U.S. Court of Appeals for the Eleventh Circuit and the Honorable Robert L. Hinkle of the U.S. District Court for the Northern District of Florida. During law school, Tara interned for the Honorable Charles T. Canady of the Florida Supreme Court and was selected to serve as a gubernatorial fellow in 2010 and 2011 for Governors Charlie Crist and Rick Scott.
