Meredith has obtained Site Rehabilitation Completion Orders from the FDEP for her clients, both without conditions and with conditions, such as institutional and engineering controls designed to limit risk exposure which are imposed through restrictive covenants. Meredith additionally has experience litigating environmental matters, including those under NEPA, the Clean Water Act, including Section 404 wetlands permitting, CERCLA, including Superfund liability, cost recovery and third-party claims, as well as those under Florida law, including Chapter 376, F.S, and common law claims.

Meredith's land use practice involves representing developers, land owners and business owners before county and municipal governments, including zoning boards and commission/council members, to obtain rezoning, variance, special exception, site plan and other development approvals, as well as to conduct in depth due diligence review regarding prospective developments.
