

Amanda Buffinton Speaks to Channel 8 News about Structural Building Inspections in Tampa Bay, Following Surfside Condo Collapse

Following the partial collapse of Champlain Towers South in Surfside, *WFLA Channel 8 News* interviewed Shutts & Bowen LLP partner Amanda Buffinton about concerns regarding the structural integrity of Tampa Bay's multi-story buildings.

According to the report, buildings are routinely inspected during construction, renovation and repairs, but are not mandated under any federal, state or local laws to undergo further inspections or re-certifications for building integrity with the exception of the 40 year recertification process, which is unique to south Florida through the Miami-Dade County Code. In her interview, Amanda noted that although structures are built for long lifespans, building materials degrade over time, especially in coastal communities or in buildings close to the shoreline.

With 625 high-rise buildings in Pinellas County alone, lawmakers have said that change related to inspection mandates is imminent. For concerned residents, Amanda advised that spotting potential structural issues like deep cracks in walls or ceilings, sagging roofs, uneven floors, water intrusions and crumbling concrete, is important. "When you see things like that – it's a symptom, and it means that there's something occurring and you want to understand what the cause of it is," said Amanda. "Maintenance is key."
