

Forbes.com Article Highlights Fraudulent Transfer Case Handled by Shutts Attorneys

In a recent article featured by *Forbes*, the publication discusses a fraudulent transfer case where Shutts partners James A. Timko, Jack McElroy and Jeff Elkins obtained partial summary judgment for a Chapter 7 trustee.

In the *Forbes* piece, "Debtor's Transfers From Non-Debtor Limited Partnership Set Aside in Cole," the author reviews the factors contributing to a complex bankruptcy case involving a limited partnership formed by a Florida real estate developer who fell into deep financial distress following the 2008 financial crash. While owing millions of dollars, the debtor began a series of transfers to exempt accounts. The transfers consisted of the dissolution of his partnership in which he owned an interest separate from his wife's and general partner's interest. Rather than receive his separate distribution upon dissolution of the partnership, the debtor caused the partnership to transfer all of the partnership assets to accounts owned as tenants-by-the-entirety with his wife and he then claims those accounts to be exempt from collection efforts. The chapter 7 bankruptcy trustee, as represented by Shutts, won partial summary judgment against the defendant with the Court finding that the debtor committed actual fraud when making the fraudulent transfers and fraudulent conversions.
