adjunct professor at the Florida State University College of Law, teaching various courses including Florida Constitutional Law, Insurance Law and Florida Alternative Dispute Resolution.

A native of Graceville, a small farming community in the panhandle of Florida, Justice Polston graduated from Chipola College in 1975 with an Associate's degree. He went on to earn a bachelor's degree, summa cum laude, from Florida State University, where he was named FSU's Most Outstanding Accounting Student and was inducted into the Beta Alpha Psi Honorary Accounting Society. In 1986, Polston obtained his *juris doctorate* with high honors from Florida State University College of Law. After becoming a member of The Florida Bar, he worked in private law practice in Tallahassee for 14 years. He was a member of the Tallahassee Bar Association and Tallahassee's American Inn of Court (former Treasurer).
