Mary Ruth Houston, Co-Managing Partner of Shutts & Bowen LLP's Orlando office and Chair of the Labor & Employment Practice Group, authored an article in *Law360 Employment Authority* discussing a recent decision by the U.S. Court of Appeals for the D.C. Circuit, lowering the bar for job transfer bias claims.

In the article, Mary Ruth discusses the reversal of a decision of a prior panel of the court by the U.S. Court of Appeals for the D.C. Circuit on June 3, 2022, which had previously held that the denial of a lateral transfer was not an adverse employment action for purposes of a Title VII discrimination claim.

The full D.C. Circuit categorically held, "an employer that transfers an employee or denies an employee's transfer request because of the employee's race, color, religion, sex, or national origin violates Title VII, by discriminating against the employee..."

According to Mary Ruth, the case, at least in the D.C. Circuit, represents an erosion of the level of materiality required for an adverse action under a disparate treatment claim, and may completely eliminate it. She also asserts that practitioners should keep a close eye on cases as the effects of this decision develop.
