Melodie's team worked with Workforce Development Partners, a local non-profit dedicated to providing life-changing opportunities for youth and adults, fostering company growth, and serving as an economic catalyst for communities. Over the course of her program, Melodie's team refined the processes of Workforce Development Partners and equipped them with skills and resources for a more efficient, scalable operation. Ultimately, Melodie's team delivered targeted solutions to Workforce Development Partners, laying the groundwork for sustainable growth and greater operational capacity.

Over the course of the program, Melodie also volunteered with Workforce Development Partners at their Business Tour and Future Fair Hiring Event. During the Business Tour, Melodie accompanied high school seniors to three different business visits from diverse industries, including a lunch program with government and training partners. Students met business leaders and current employees, asked them questions, and opened their minds to what is in their community.

At the Future Fair Hiring Event, there were 50+ employers, training, and community partners with comprehensive and diverse jobs and resources. Among other things, Melodie chaperoned breakout sessions where students learned from local community and business leaders.
