

My Summer Associate Experience: Zachary Amrose

How did you decide to pursue this position?

I learned of Shutts while I was searching for summer associate positions near my family in South Florida through which I would be exposed to business litigation and a variety of other practice areas. I also improved my research and writing skills, learning to more effectively separate the wheat from the chaff. And after first seeing an assigning attorney meaningfully engage with my research product, I earned confidence in my career path.

What were your expectations and have they been met (or exceeded)?
