

# My Winter Clerkship Experience: Raymond L. Cordova

Our 2021 Winter Clerkship Program brought six law students for an intellectually challenging and professionally gratifying experience. The program normally takes places during the summer, but was postponed due to the COVID-19 pandemic. #### How did you decide to pursue this position?
