

## Nicholas Meros Appointed to Second Judicial Circuit Judicial Nominating Commission

Governor Ron DeSantis recently announced the appointment of Shutts & Bowen LLP Tallahassee partner [Nicholas Meros](#) to the Second Judicial Circuit Judicial Nominating Commission (JNC), with his term running through July 1, 2027.

The 27 separate JNCs act as the panels that recommend lawyers for judgeships, selecting nominees to fill judicial vacancies within the Florida court system. The Supreme Court, appellate districts, and circuit JNCs consist of nine members, all of whom are appointed by the Governor.

"I'm honored to be appointed by Governor DeSantis to the Second Judicial Circuit Judicial Nominating Commission," said Nick. In 2023, West Palm Beach partner [Patricia M. Flanagan](#) was appointed a member of Florida's Fourth District Court of Appeal Judicial Nominating Commission.
