The article discusses a Florida trial court's ruling that a party can constructively waive an argument that an arbitration award should be vacated on the basis of alleged arbitrator partiality if the party, through reasonable diligence, should have been aware (even if they were not actually aware) of the facts underlying the claim of alleged partiality, but failed to assert that argument until after the entry of the final arbitration award. Patti and Ella were lead counsel for their client in the matter referenced in the article, and were successful in the arbitration, trial court, and subsequent appellate court proceedings.
