

Timothy Woodward Interviewed by Law360 for Coronavirus Q&A

Timothy Woodward, a partner in the Tampa office of Shutts & Bowen LLP and leader of the firm's Construction practice group, recently participated in *Law 360*'s Coronavirus Q&A, discussing the pandemic's impact on the construction industry and the adaptations made by key players in the business.

As part of a series of interviews by *Law360* to discuss the ways COVID-19 has impacted businesses and the law, Tim shared his thoughts on the state of the construction industry before the pandemic, how the coronavirus has restricted the industry and created new legal challenges, what differences he has seen between project sectors and what he has noticed with respect to litigation.

He noted that the construction industry has readily adapted to added protocols put in place to safeguard against virus transmission, thanks in part to the heavily regulated nature of the industry. Although businesses have mostly been able to maintain operations, Tim provided insight on various challenges in the industry, including project delays and cancellations, as well as lending issues. Discussing COVID-19's impact on litigation, Tim noted that "anytime the economy takes a dip in construction, then parties who are owed money have less tolerance to wait for it."

"They're going to exercise their lien rights or bond rights and bring their claims earlier to make sure they're the squeaky wheel. So there's an uptick in people trying to get paid for the work they've already done," he said. "They're not willing to wait for that receivable to be really old before they call us, their lawyers."
