Olga and Ella will break down the Helms-Burton Act with particular focus on the more controversial right to private action against persons trafficking in properties confiscated by the Cuban government, as now permitted under the Trump administration. The "unleashing" of litigation under these provisions may be of particular relevancy to U.S. subsidiaries of foreign companies, as well as to foreign companies with assets or affiliates in the United States.
