Fellow sponsors of the Broward events included the T.J. Reddick Bar Association, and the Gwen S. Cherry Black Female Lawyers Bar Association, and the H. Wayne Huizenga School of Business and Entrepreneurship at Nova Southeastern University.

Mr. Calloway welcomed Dean Garon in unveiling Nova's Global Law Leadership Initiative, an elective immersion curriculum beginning with the August 2015 entering class designed to develop the technological, financial, and global competencies essential to modern law practice, incorporating an international perspective and promoting minority empowerment.

"This is important for professional development of Florida's young law students and lawyers as well as for the growth of the community," said Calloway, Co-Chair of the firm's Government Law Practice Group, longtime legal and civic leader, and powerful mentor to aspiring lawyers for more than two decades. Mr. Calloway is former President of the T.J. Reddick Bar Association and former Chair of the Greater Fort Lauderdale Chamber of Commerce and current member of the 17th Circuit Judicial Nominating Commission.
