TWO EXPERIENCED TRIAL LAWYERS JOIN EXPANDING TAMPA OFFICE OF SHUTTS & BOWEN LLP

TAMPA, Fla. - The Florida law firm of Shutts & Bowen LLP announced today that veteran Tampa trial lawyer John "Sean" Johnson has joined the firm's fast-growing Tampa office as a partner, and litigator William Cassidy has become a senior associate. Johnson previously was a shareholder and Cassidy was an associate with the Tampa-based law firm of Trenam, Kemker, Scharf, Barkin, Frye, O'Neill & Mullis, P.A.

Wyle Electronics, which was featured in the National Law Journal as one of the top 10 defense verdicts in the country in the year 2000. After a five-month trial in state court, which was the longest civil jury trial in Hillsborough County history, jurors ruled in favor of the defendants, rejecting Avnet's \$154 million tortious interference claim.

Shutts & Bowen's sixth Florida office was opened in March 2006 with four attorneys and now has 20 lawyers based in Tampa. Shutts & Bowen's full-service Tampa office represents clients in corporate and securities, mergers and acquisitions, government contracts, intellectual property, commercial litigation, real estate, banking, tax, bankruptcy, health care and employment law matters.
